**MOTIF / REASON:**

The Stewards having received a report from the Judge of Facts (Doc n° 61) requested by the Race Director, having examined this report, summoned and heard the Driver and Competitor concerned (Summon Doc n° 119), have considered the following matter, determine the following:  
\_The above-mentioned Driver pushed another Driver – an incident as defined in Art. 2.24 of the CIK FIA 2024 General Prescriptions.  
In the session concerned by MP 2 he pushed the kart (kart n° 119) and following of this manoeuvre Driver n° 114 lost positions.  
\_This fact is a violation against the Art. 3.6.2 e of the 2024 FIA International Sporting Code of Driving Conduct.  
\_The Stewards impose this penalty according to Art.2.24 of the CIK FIA 2024 General Prescriptions and Art.12.4 of the 2024 FIA International Sporting Code.  
The Competitor is reminded that, in accordance with Art. 25 of the 2024 CIK Specific Prescription, the above penalty is not susceptible to appeal.
